- Possible voting members; Past Delegates, Archivist and Webmaster. Currently they do not vote. Questions raised: If they become voting members, does that change the role call and the quorum? Questions and concerns noted:
 - -The reason decided to make these non voting members is their position is a non rotating position. Concern with possible control of the vote.
 - -Are these two separate ideas? 1. Quorum- Will they attend the Area meetings 2. Granting Past Delegates voting.
 - -Where is the spirit of rotation? When do you "pass it on"? Will the past Delegates be there, but if not at Area functions, why would they get a vote?
 - -Not in support of either idea. But, Past Delegate is informed of Area activity by reading the Area minutes. As a group member, they speak up and will continue without a vote.
 - -Questioned if the thinking the reason for having past delegates vote is "their vote is more of a value; they know the inner

workings of AA. New area members are not informed. Votes are based on confusion.
