# Registrar's Report:

The following letter from GSO was read:

Dear Friends,

Warm greetings from the GSO Records department. As you may have heard the GSO is in the process of upgrading our multiple computer systems/databases into one system-ERP (Enterprise Resource Planning). The current Fellowship New Vision (FNV) database will <u>eventually</u> be folded into the ERP system.

The cutover of the systems will begin at the close of business Friday, July 26, 2019 and continue until the go-live date of the ERP system on Monday, August 5, 2019. During the time mentioned all internal GSO systems and our three warehouses will be down so no work can be processed. In preparation for the cutover of systems we will restrict your access to FNV beginning Friday July 19, 2019. The reason being is to allow all updates for GSRs, DCMs, DCMCs and New Groups to reach our warehouses, where the requests for GSR, DCM, DCMC and New group kits go to be fulfilled before/by July 26, 2019, which is the shutdown date for all GSO internal systems/databases. During this period, you will be able to view your area information, create group information sheets and spreadsheets. However, you will not be able to update information into FNV.

To ease your minds a decision has been made to run FNV parallel with the ERP system for a few months. When we go live (August 5, 2019) you will be able to resume use of FNV to update records until further notice. Because we will be running parallel systems the information entered into FNV will be migrated into the new system 2 or 3 times per week.

Once the new area registrars' portal is ready for use the GSO will reach out to all registrars with more information.

## **Accessibility**:

The Accessibility Committee met on Wednesday June 26, 2019. No new referrals for services had been received. A poster board suitable for display at conventions, roundups and assemblies has been completed and was presented. It was suggested that a protective sheeting would help preserve the written information on the board. Members took a handful of the new Accessibility pamphlets to distribute to their areas, home groups, etc.

A deaf member shared his experiences with a voice recognition application called Speechnotes, which converts speech to text. It is available for Android users. It has limited range (about 10 feet). The member has used it at speaker meetings when he has spontaneously decided to attend a meeting and does not have an ASL interpreter with him.

The Committee would be interested to learn of IOS (iPhone) users who have had similar success using speech to text technology.
