- AA World Services is working on a release of the book "The Twelve Steps and Twelve Traditions" in American Sign Language format on DVD that will include spoken word and subtitles
- NERAASA will be held on February 21st through the 23rd in Nashua, NH
- Registration is open for the International convention in Detroit in 2020
- A former trustee at large from our area was hired as a consultant to the General Service Office
- The Communication Service Department has been started at the General Service Office
- The January Concept meeting will be teleconferenced with the Berkshires

#### **Alternate Delegate Remarks:**

Mention the early numbers from the International Convention being held from Thurs 7/2-Sun 7/5/20. Over 10,000 registered on the first day and 35,000 plus now.

Review NERAASA and the fact that it will be held 2/21-2/23 in Nashua New Hampshire. It's for anyone involved in or considering getting involved in AA service. They will have break out meetings for GSR's, DCM's' Delegates and all the other various committees.

GSO now has ASL versions of the big book, and the 12 steps and 12 traditions, also the 12 concepts are now in an audio version and you can listen to them from the AA web site.

The next General Service Conference will be held from April 19-25<sup>th</sup> in Rye Brook New York.

The agenda topics are still being developed but here are some items as a sample of what will be coming:

- 1. Consider an amendment to the title of the booklet, Living Sober, to read Living Sober: How to not take the first drink.
- 2. That literature be developed sharing experience, strength and hope on meditation.
- 3. That the conference considers creating a 5<sup>th</sup> addition of the big book and remove chapters "to the wife's", "The family afterward" and "To employers".
- 4. Consider an individualized workbook to accompany the Big Book (carried over from last year).

#### **Old Business:**

- A second vote was taken and the minority opinion won meaning the original motion was back on the floor
- More discussion ensued, the question was called and a vote was taken
- The vote ended in a tie with the deciding vote in favor of increasing the reimbursement rate being made by the area chairperson
