Contact GSO give them you experience and they would be happy to give you direction, other grps experience. Suggest the district do discuss this topics with their district and GSRs. Not naming Grp or individuals. Topic needs to make it out there. Education issues, continue this discussion on and on.. Can see a pamphlet coming out, will take a long time but I see one in the future.

Not attached to the dollar amt but 25 % of our budget is \$7K, think we should bring it up at assembly. Area should use the money 1st but we are just sitting on it and it just keeps growing.

Motion is not carried.

Reminded what came out of finance mtg: if your committee has a need for something, now is the time to request extra funds. We have the money to provide to our area. Need literature, materials for committee. Hopefully come back with request either at assembly or April area mtg. Educated what our funds look like month to month. How many times have we fully support all committee members to NERAASA or delegate going to the conference.

Thought: if in the future if area is getting above certain percentage or money amt. contact the individual grps and tell them to give it to the other entities. Because we have a listing of what grps contribute.
