#### **VIRTUAL GROUPS**

The Trustees' Ad Hoc Committee on Participation of Online Groups in the US/Canada General Service Structure reported on its progress at the last Conference. Our Delegate, Mike, mentioned this in his Conference Report, and generously sent me a copy of the Trustee presentation. Trustees are mostly gathering information and suggestions right now. One interesting fact is that there are now almost 600 active virtual groups registered in the US and Canada.

- The area registrars are also trading information and experience with virtual groups and virtual districts.
- Here in Area 31, we have 2 registered virtual groups. But many of us know of groups meeting online only, and I've started to build a list of those. It looks like we have around 30. More info to come. Any group that wants to be registered as a virtual group should know that it is easy to change their registration type from "regular" to "virtual." When GSO tell us there are 600 virtual groups, we want Area 31's groups to be represented in that number if they want to be, and to have a voice as AA develops policies for their participation in the service structure.

Jack started the meeting with the Serenity Prayer and a review of the GV Chair meet and greet held by the GV Editor last month. The biggest news from that is that the staff is aware of the issues with the online ordering process and are looking into improving it. We then watched a video on the responsibilities of the GVR from the Grapevine You-Tube page and discussed all of the great videos and stories available on You Tube.

Jack visited a couple of groups to talk about them getting a GvR. We had the GV Board at the Cold Spring's 47<sup>th</sup> Anniversary meeting last month and there was a good response.

The Grapevine is working on an all-inclusive app for the Grapevine, this should be out in a year or so. Jack reviewed the July GV News including the Editors deadlines.

We have not heard back from them as of yet. In July Meeting Adcare came up again and it was decided that John M would make contact with Annie, the Outpatient Program Director. John M reported on his recent communication with Matt at Audacy Radio concerning our Radio Show to give him a couple new names and inquire about times available to record since we have received few concerns about this. Matt said there have only been five shows so far. He has had a hard time getting together with volunteers. The only times available to do this are Tuesday, Wednesday, Thursday from 1 to 4 pm due to other Station use of Studios. John is going to redo the Information sheet with this so everyone will know this in advance. Also Matt said our show is aired on Sunday at 5am on 94.7 and on 98.1 at 6am when available. A lot of discussion was had by three Reps here last night about past Committee's commitments and more Rep participation. All three had past experience in PI. Marc C will compile a list for High Schools done in the past for us to reach out to in September. Cooley Dickson was brought up and Peg will contact. Mark H will try to reach out to the Second Offender Program in Northampton again.
