## Registrar's Report : NUMBERS:Registrar's Report

NUMBERS: Area 31 currently has 303 registered active groups ( 301 regular +2 virtual). VIRTUAL GROUPS: AA has had online groups well before the pandemic, but the numbers exploded starting in 2020. Two Advisory Actions at the 2021 General Service Conference said that the Conference structure would recognize online groups and encourage their participation, and that the General Service Board would form a committee to explore ways for online groups to participate in the service structure.
There's been a lot of activity since then, including: the addition of a "virtual" category in Fellowship Connection, reports to the 2022 and 2023 General Service Conferences from the Ad Hoc Committee on Participation of Online Groups in the US/Canada Service Structure, the creation of virtual districts in at least two areas that I know of, and requests that the Conference consider creating a virtual area.
Here in Area 31, two groups are registered as virtual. I've been encouraging groups and districts to let me know if there are other groups out there that should be added to the virtual category. But groups are understandably more focused on making sure their meetings are correctly listed. Getting the Fellowship Connection list right is more my job. Using the data that Bob B. maintains for Intergroup, which is the data that feeds the Meeting Guide app and the meeting lists on our area web site, l've found 16 groups that, as of now, are online only. Those are the 16 on the top half of the handout.Two of the 16 are already registered as virtual. I'm going to move the other 14 into the virtual category. This is easy to do,and it's easy to undo. So we can add and remove groups going forward.This will make our records more accurate, and more in line with the way other areas handle this. It could also help the virtual groups take part, if they want to, in conversations about supporting such groups. The chart also lists, at the bottom, online meetings that are not registered groups.
