And that was very well received..District 1 met at Sacred Heart Church on Everett Street in Springfield, by Mercy Medical Center. 5 groups from District 1 were represented at the meeting. We had two invited guests; Ray (Alternate Delegate) and Bruce (CPC Chair). Bruce spoke about what CPC is and how they interact with the professional community in Area 31. Ray discussed various topics upcoming for the Area; such as the golf tournament, Round-up, State Convention.

Sally, the Area Registrar, and Yolanda, the Chair for Intergroup, both came and gave wonderful presentations and gave insight into the functions they perform for the Area which benefits all AAs. This meeting was short, there were no large issues, most groups are reporting that they are continuing to grow, see new faces and contributing to the pie chart. The items of particular mention are:

The Holyoke Group just celebrated 78 years. They are seeing some old faces returning as well as new members. Sober Sunday in Holyoke reports that one must come early to get a seat for the meeting and that they are getting active in other areas of service.

Pioneer Valley, West Springfield, reports that they are looking for members. They held a Memorial Day Pizza party. They are back to doing a commitment at Carlson Recovery, on the last Friday of each month.

Wild Cats held an anniversary party on May 27th, 4p-7p, it was a potluck dinner.

The 164 Big Book group in Agawam reports that they are gaining steam, with 12-15 members. They were large when they started and things seemed to diminish for a while. They now are currently attracting 40-50 in attendance each meeting.

Daily Reflections, a Zoom meeting, is still accounting for a large attendance each day and that the attendance demographics are diverse, it is viewed/utilized in several states, as far as Arizona and even in South America's Argentina!

I gave my report from Area,I emphasized the GSRs' responsibilities- esp. concerning their attendance at the Round Up and Assemblies. Unfortunately, we did have another issue with getting the Zoom feature to operate. I had pre-arranged with one GSR, who had been locked out in another previous technological snafu, to call me and we tele-transmitted the meeting. Our Co-DCM was also counting on Zoom and she was able to contact a friend, who is one of the GSRs, and was able to tele-transmit to her also.
