## **GROUP REPORTS**

- 8. Monterey 11th Step: Meeting is Monterey and meets outdoors even in the winter; noted that two members are going to attend NERAASA.
- 9. Big Book Group, Cheshire: Group meets on Wednesday nights @ 7:30. They have a changing format and have decided to eliminate their PayPal account.
- 10. I Don't Have a Clue: Hosted a successful Christmas Day Zoom-a- thon, meeting size varied from 6 to 12 participants. The intimate meetings were enjoyed by all. The position of Business Meeting Chairperson opened and remains open.
- 11. Keep it Simple: the group has 3 institutions commitments a month and is no longer doing the Jones commitment; the group elected a new alt GSR, Brian C
- 12. Lee Young People's: five upcoming anniversaries this month; currently have an institutions rep and a BIG rep, an alt-GSR is needed; the group sent extra money to GSO this month; new people joining, good attendance and lots of cake, still looking at having a group anniversary in the spring.
- 13. Lenox Big Book: Continues to be a well-attended meeting; they are currently looking at changing the format of the meeting and will may eliminate the PayPal account due or lack of use; group positions are all filled and they have a BIG rep and an Institutions Committee rep.
- 14. Northern Berkshire Group; The group continues to take steps to hold a Group Inventory in the Spring; group will be hosting a post-holiday potluck dinner on February 4th (a week before the Super Bowl) @ 6:30 pm; the group assigned a new position to organize and coordinate speakers from local meetings coming in, and going out from the group; currently positive attendance and the group is sending money to GSO as support.
- 15. Pittsfield Men's 12th Step Group: The group has an institutions' commitment @ CSS and renewed their subscription to the Grapevine and LaVina which is distributed to the jail as a gift; the group contributes according to the pie chart and is in discussion about a need for alt-GSR position or treasurer.
- 16. Stockbridge Tower Group: The group has all service positions filled including monthly commitments to CSS and McGee and the group is inspired to have more opportunities for fun and fellowship; group has three anniversaries this month and will have ice cream cakes for the

celebrations; the group is entertaining the idea of hosting a spring dance party at the Southern County Recovery Center in Great Barrington; attendance generally between 40 to 60 people inperson and 6 to 12 typically on Zoom.

- 17. Sober at Sunrise: The group meets daily from 7 to 8am at the Crane Center in Pittsfield and attendance ranges from 35-50 people; They have an Institutions Commitment @ CSS on the third Thursday of the month; the group's treasurer is changing and the group is still seeking an Institutions' and BIG reps; Contributions were spent evenly between GSO and Area31; SAS is offering more opportunities for members to do service at the group level, right now the coffee maker chooses the chair, and roles are offered for reading how it works and the steps; attendance is 35 to 50 and the business meeting is first Saturday of the month but is not that well attended.
- 18. Southern Berkshire Group: Coffee and cookies will make their return since hygiene guidelines have relaxed at the Community Center; the group currently is looking for an alt GSR; the meeting chair via the update format now has the choice to close the meeting with either the Lord's Prayer, The Responsibility Pledge, or The Serenity Prayer; based on the GSO letter the group is giving 50% to GSO for the rest of the first quarter.
