GROUP REPORTS

- 8. Big Book Group, Cheshire: Group meets on Wednesday nights @ 7:30. Currently the group has an institutions commitment that regularly brings meetings to Mcgee, the group is still looking for an intergroup rep to send to Berkshire Intergroup.
- 9. Boiled Owls: The group meets on Monday nights at 7pm. The group is figuring out how to open a bank account and decided not to have celebrations as part of their meeting format but does track day counts. For any groups members who would like to celebrate they are invited to do so after the meeting.
- 10. Berkshire Alphabet Soup: the group which meets at the Front Street Gallery in Housatonic holds its business meeting the last Monday of the month after the regular meeting. Attendance ranges from 2-20 is making rent and doesn't have any surplus. The group will be registering to make it official.
- 11. Great Barrington Women's Meeting: The group meets on Thursday nights @ 7pm in the same space as the Keep It Simple Group- the need for dehumidifiers was expressed and the GSR for the KISG offered to bring a couple of dehumidifiers; problem solved! The group donated \$10 toward supplies for the shared space. The group elected to not participate in Bookie Meetings.
- 12. Great Barrington Men's Group: Meeting continues to average 100-125 attendees. The group continues to hold a Sunday Step meeting at 7pm. The group has a new PI (Public Information) representative, is flush with commitments, and will look at the position if Berkshire Intergroup representative next month.
- 13. I Don't Have a Clue Group: The business meeting is the last Sunday of the month following regular meeting. The group will have a picnic on Sunday, July 20th for group

members and invited guests. This will be the third group picnic, and gives local members of the now all virtual meeting a chance to be meet at a local venue. With some group members living far afield, the group will consider venues that support hybrid participation for the next gathering. Also, the group will be preparing financially for their picnic next year to be open to the entirety of District 3.

- 14. Keep It Simple Group: The group meets every day except Sunday, and its business meeting is hybrid. Holding quarterly business meetings is up for discussion. The group is developing a bulletin board to provide for greater and easier accessibility to information.
- 15. Lee Young People's Group: The business meeting is the 3rd Monday of the month. The group gives to the pie chart and has commitments to CSS, the jail, and McGee. The group will be addressing the happenstance of representatives who are not attending the committee meetings for which they have volunteered.

19. Berkshire Intergroup, Courtney, Chair

The business meeting is held the 2nd Monday of the Month @ 7pm on Zoom. Bookie Meetings will have a hybrid meeting at 6pm on the 2nd Monday of the month for the business of the meeting exchange. Group exchanges via bookie meetings begin in August. The BIG sponsored picnic will be held on July 13th at the Pittsfield State Forest. BIG purchased 100 "When & Where" meeting booklet and had about 60 remaining. "When and Where" booklets can be picked up at the BIG office and a donation is suggested. 2025 will be Berkshire Intergroup 's 35 th year. BIG is considering staggering the timing of the Secretary and Treasurer service

positions. Positions currently rotate simultaneously, causing concern for a thorough passing forward of experiential knowledge of the workings of BIG.
