All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness. "

#### **GROUP REPORTS**

- 8. I Don't Have a Clue Group: IDHAC four month commitment for the chair appears to be working well and looking to fill the roles for treasurer and secretary; the IDHAC group is working on a Zoomathon or virtual thanksgiving and Xmas and 6 or 8 hour window for the event.
- 9. Lenox Big Book Group: Lenox BB still has around 30 in attendance during summer and the fall is booming as well; there is a good core group and young people and the group is contributing to pie chart; group has institutions commitments including Tuesday to McGee; Dennis F. is celebrating at the end of September.
- 10. GB Men's Meeting: Men;s meeting commitments to Berkshire County House of Corrections, CSS, and McGee; the online step virtual meeting on Sundays at 7pm is doing well and is available on Meeting Guide App; the group will hold a picnic at Sheffield town park from 12 to 5pm, food will be provided and group members bringing potluck open to all.

- 11. Boiled Owls: Boiled Owls meeting has good attendance from 7 to 20, currently no desire to celebrate or take on commitments.
- 12. Alphabet Soup: Meeting is an LGBTQ+ meeting that meets on Monday at 7pm, 5 members of the group and 10 attendance last Monday; business meeting is after the last Monday meeting of the month.
- 13. GB Women's Meeting: The meeting is Thursday at 7pm and is anchored by a small core group; still need to fill service positions in the group and the Berkshires; group is talking about a commitment at McGee or CSS; the group provides welcome packets to new women to the meeting; the group is discussing the number of PLBB books to order.
- 14. Southern Berkshire Group: Chris the alt. GSR will be taking over as the GSR; the group has good attendance (60 to 80) between in person and virtual; commitments in the group and to institutions are being filled, elections held and new positions that have started immediately;
- 15. Keep it Simple Group: WiFi now is working well in the space in the basement; quarterly business meeting was held and had a record number of people; the Saturday noon meeting will now become a hybrid meeting with the whole group rather than two separate meetings due to the new wifi access; looking at mechanical equipment for air flow with new dehumidifier.
- 16. Tower Group: meeting is on Tuesday at 8pm and is hybrid; service positions in the group are filled; group has three outgoing commitments to institutions; a dance is to be held at the South County Recovery Center at the end of the Month.
- 17. Berkshire Big Book: meeting is in Cheshire at 730pm on Wednesday, hour and a half; treasurer will be needed at the end of the year as the current person is rotating out; group has a commitment at McGee and commitment is filled, 20 or so in attendance weekly.
- 18. 8/16/24: District 3 will hold an 'Emotional Sobriety Workshop' sponsored by District 3 on Saturday morning in October 5th at First Congregational Church, 4 Main Street in Stockbridge, MA; the topic will "emotional sobriety: from the promises to the bedevilments"; there will be 8 speakers and the committee is still looking for speakers for the event; ten-minute speaking parts with breaks, Q & A, ask it basket; pastries and coffee will be provided; the flier due out in the next week or so; noted that the event may

go over the budget allotted to District 3 and can be brought before the Area Committee for approval **over** the overrun but there is no guarantee.
