Group Reports: All GSR's gave reports on news from the groups they represent.

Issues for discussion from the group reports included new group members who make changes to a meeting, groups that have a large number of members but only a few members at business meetings, contributions to GSO, Area not listed in reports, what should be included in Newcomer Packages, the difference between a Group Conscience and a Group Inventory, what does it mean when a GSR says, "All their positions are filled?", the role of sponsorship in getting those positions filled.

Carl reported that two items were voted on and approved at the Spring Assembly: to make the Webmaster a non-rotating, non-voting officer of the Area Committee, and a motion that laid out the process for 3rd legacy voting at the next fall assembly. That process is:

- B. Qualifications for the position are read
- C. Any who do not meet that qualification sit down.
- D. When all qualifications have been read, the names of all those that remain standing are placed on a board for voting.

District 6 will be responsible for two workshops at the Round-Up; Sponsorship and Step 1.

Jim S. Reported that a representative of WMYPAA would be attending the May District Meeting to give a report. Also, a second part of the GSR presentation would be upcoming.

Delegate's Report: Brian reported that he will be leaving for the General Service Conference in New York. He also gave a preview of the upcoming Round-up, and pointed out that those interested in attending the NERF should register on-line
