The Impact Collaborative did a communications audit with the General Service Office (on pamphlets, website, literature). The audit report is available at the Area website, if you are interested.

Box 459 "Myths and Misconceptions": A 2014 survey showed 12% of AAs were introduced through the Judicial System. Healthcare, addiction, and the law are the primary conduits to AA for new members.

"Sharing from behind the walls": Testimony from an incarcerated alcoholic relays his story of gratitude for AA from within prison.

Alcoholics are not the only ones who carry the message. Both accounts highlight the importance of professionals and other non-alcoholic friends of AA who have helped AA grow. Also included is the story of Dr. Clinton Duffy of San Quentin and his impact on AA.

## **Berkshires** – Chaula was here and gave a report.

This will be her final meeting with us, as another chairperson has stepped up to lead the Berkshires Institutions committee. She is grateful for everyone's support! All but four meetings in the region are covered at this point. The substitutes list has still been a huge asset in covering commitments. There have been many new requests from skilled nursing facilities... in Berkshire County, detox and CSS facilities are so overwhelmed (five facilities have closed) that skilled nursing facilities are now taking detox patients. Social workers are becoming certified to cover the need. Four new requests have

come in this month from nursing homes... they are challenging because attendance at the commitments can be low or spotty. As a result, the Berkshires is offering a once a month three-speaker meeting at one facility (Hillcrest Commons) that is being used as a training ground for new speakers. Also, Chaula has found a replacement! Connell! Welcome!

Erick gave definitions of "Roll Ins" and "Roll Outs"; it is suggested sponsors have one year of sobriety, and alternates have 6 months of sobriety.
