A couple of updates: Paul was on a meeting today, and there was an announcement that there is a new female Section 35 facility coming to the area. It is expected to open later this year. The General Service Conference was held, and complete materials will be available later this month or next. A motion passed to change the preamble to read that AA is a "fellowship of people", rather than "men and women". The motion passed with a substantial majority. Technically, the Grapevine owns the preamble, and so the change was made with their cooperation. Another change was made to change "inmate" and "offender" to "persons in custody" in AA literature. Although this motion initially did not pass, a comment during discussion indicated that Oregon has banned all literature using the word inmate, and this substantially shifted opinion. NERF is coming up on Saturday, June 4-6, with workshops and more. It is free, the link is on our website, area31aa.org.

Craig, CPC - the committee has been meeting regularly on Zoom, practicing presentations, and trying to make inroads to facilities where they might present when things open up following the pandemic. Bay State Health Psychiatric Unit and Clean Slate have expressed interest already. The Visiting Nurses Association, Western Mass Addiction Providers Association and others are also on the list for outreach.
