#### Librarian- JD

Dispersed a total of 154 assorted books last month. \$1,390 spent on book orders. 913 books on hand. As mentioned last month, Grapevine prices going up by \$2.50, but we got lucky this month because there was still some old stock available at the previous price, which means a couple extra books for us.

• Betty holds a commitment at a women's prison, and needs to send an email in advance with the number of books she's bringing in. All the books get checked upon entry.

- Bruce holds a section 35 commitment and had to get permission from a supervisor to bring in books. This particular institution had a budget and actually bought and brought in books themselves.
- Phyllis; Weekly commitment at a women's prison and has never had an issue, takes books and pamphlets in all the time.
