- A. District 3 CPC Update
 - 1. District 3 CPC was created to focus on institutions specifically within Berkshire County.

 - (1) Eight "seasoned" AA's were in attendance. CPC videos via GSO were played, and discussions were had re: visiting Berkshire Medical Center, Fairview Hospital, and the Bar Association.
- B. Understanding Anonymity review
 - 1. Due to the media presence at the recent substance abuse fair that CPC attended, the committee chair felt it would be beneficial to discuss anonymity among committee members. At the previous event, the media was respectfully asked that faces of AA members not be shown as affiliated with AA. 22 News respected the request and featured information about AA's attendance while respecting the anonymity of the individuals present.
 - a) Anonymity is an individual decision and it is each person's choice if they would like to identify as an alcoholic when speaking with a professional one on one.
 - b) When dealing with the media/public, no AA should be in photos, or introducing themselves as aligned with Alcoholics Anonymous.
 - (a) This is per GSO guidelines
 - c) Tim suggested the committee drafting a card for CPC members with a simple statement along the lines "I don't represent Alcoholics Anonymous...."
