March 11, 2024

## **IT ad hoc committee:** (Rusty C, chair)

Hotline

Some discussion took place. The majority of the committee voted that a live 24/7 reception is preferable to a call forwarding service. Concern was expressed that the service could be improved; that calls are sometimes not returned. It was expressed that the idea of training, a workshop or more guidance on how to be effective as a hotline volunteer might be useful. The "script" used by the receptionists might be worth taking a look at. Sam reported that the reception service cost \$170 or more for 6 of the past 8 months and \$300+ for the others.

### Payment alternatives at the office

Rusty reported that setting up a credit card option would be difficult and expensive.

The options of PayPal and Venmo with a possible QR code were discussed. Sam noted that since we are not a 501 3c, we would not be eligible for a lower fee rate. Ray said the area is registered as such.

Robin reported that interest in alternative options for payment is expressed less than once a week. Currently approximately 60% pay with cash; 30-40% by check.

One person thought an alternative payment method might be attractive to younger members and newcomers. Most did not perceive a strong need to go further.

Phone service

Services, including cloud-based, that could offer significant savings are being investigated.

The interest of many to have the option of being able to print meeting lists on  $8 \frac{1}{2} \times 11$  paper in a spreadsheet format is in process.

#### **New business:**

The idea of planning an event was tabled pending additional feedback from reps.

The proposal of whether or not documents such as committee minutes and bylaws should be posted on the website was tabled.

Meeting closed with the responsibility pledge.
